Mr. Gee has been in the forefront of the legislative and referendum issues enabling that tax assistance to cultural institutions and public parks. He currently sits on the Board of the Salt Lake County/Salt Lake City Cultural Core, which is charged with developing an arts district in Salt Lake City.

Mr. Gee also presently sits on the Boards of Red Butte Garden, Pioneer Theatre Company and The Alta Club. He was previously on the Board of the Utah Humanities Council.
