Kass Wallin is a member of the Natural Resources, Energy, and Environmental Law group. He also completed a clerkship for Judge David Nuffer in the United States District Court for the District of Utah.

Before attending law school, Kass actively participated in the Hinckley Institute of Politics and was selected for an internship in Washington, D.C. for a former United States congressman. Kass previously served on his city's planning and zoning commission and currently serves on the board of his community's homeowners association.
