Stanley Neeleman practices law in the areas of federal taxation, estate planning and business planning. He is a professor emeritus of law at the J. Reuben Clark Law School, where for over 30 years he taught courses in income and transfer taxation, estate and business planning and professional responsibility. Prior to joining Parr Brown as of counsel, Mr. Neeleman was a partner at Holme Roberts & Owen, Denver, Colorado.
